

#### AB 87 | Pupils: Section 504 Plans

Meetings and Team Meetings Effective January 1, 2024 EC 270

- Grants parents, guardians and LEAs authority to make audio recordings of Section 504 meetings
- Parent, guardian or LEA must notify team members of intent to record meeting at least 24 hours in advance
- If LEA notifies team of intent to record meeting, and parent/guardian objects or refuses to attend meeting because it will be recorded, the meeting shall not be recorded



### AB 230 | Menstrual products

#### Menstrual Equity for All Act of 2021 Effective July 1, 2024

EC 35292.6

- Amends current law and requires LEAs that maintains any combination of classes *from grades 3 to 12*, to stock the school's restrooms at all times with an adequate supply of free menstrual products, available and accessible, in all women's restrooms and all-gender restrooms, and in at least one men's restroom.
- Notice shall also be placed in a prominent and conspicuous location in each of the required restroom sites and shall include:
  - Requirement to stock the restroom with free menstrual products
  - Identify the person responsible for menstrual product supply, including email address and telephone number



### **AB 245 | High School Athletics**

California High School Coaching Education and Training
Program: Emergency Action Plans EC 35179.1, 35179.4
Effective July 1, 2024

- Adds to HS Coaching Education & Training:
  - Recognizing & responding to signs/symptoms of cardiac arrest
- If LEA or Charter school offers interscholastic athletic programs, must have:
  - Written emergency action plan (EAP) that includes manner & frequency EAP will be rehearsed
  - Shall be posted
- Require certification in use of automated external defibrillator (AED) in addition to CPR and first aid
- Companion bill AB 1653



### **AB 659 | Cancer Prevention Act**

#### Effective January 1, 2024

EC 48980.4, HSC 120336

- Requires 6th grade notification to parents/guardians advising pupils adhere to current immunization guidelines, including human papillomavirus (HPV) before advancement to 8th grade
  - HPV can prevent >90% of cancers caused by HPV
  - HPV not a requirement for advancement



### AB 1283 | Pupil Health

#### Emergency Stock Albuterol Inhalers Effective January 1, 2024

EC 49414.7

- School districts, COEs, and charter schools may make emergency stock albuterol inhalers available at schools
- School nurses or volunteer trained personnel recommend 2 trained personnel
- May administer an albuterol inhaler to persons suffering, or reasonably believed to be suffering, from respiratory distress
- CDE to post training standards for administration of stock albuterol inhalers



#### AB 1466 | Pupil Discipline

Restraint and Seclusion: Reporting Effective January 1, 2024

EC 49006

- Requires LEAs to post restraint and seclusion data on their website
  - Current state law requires LEAs to submit their restraint and seclusion data to the California Department of Education annually



#### **AB 1651 | Pupil Health**

Emergency Medical Care: Epinephrine Auto-Injectors EC 49414 Effective January 1, 2024

- Munoz Student Allergy Framework for Emergencies (SAFE)
   Act
  - Store epinephrine auto-injectors in an accessible location for emergency use
  - A copy of written materials shall be made accessible, such as publicly posting at location of epinephrine auto-injectors
  - Annual staff notification to include location of epinephrine auto-injectors on campus



#### AB 1653 | Interscholastic Athletic Programs

Emergency Action Plans: Heat Illness: Guidelines

Effective July 1, 2024

EC 35179.4, 35179.8

- Emergency Action Plan (EAP) to include heat illness guidelines
  - Current law requires written EAP for sudden cardiac arrest and other medical emergencies
  - CIF & CDE to develop heat illness guidelines, procedures and safety standards for prevention and management of exertional heat illness
    - Shall identify environmental conditions at which a school shall limit and prohibit practice and play
  - Manner & frequency EAP will be rehearsed
- Companion bill AB 245



### **AB 1722 | Pupil Health**

Credentialed School Nurses, Registered Nurses, and Licensed Vocational Nurses EC 49426.5, 49452, 49455 Effective January 1, 2024

- If an LEA is unable to hire a credentialed school nurse (CSN), LEA may hire an LVN (through January 1, 2029)
  - LEA must seek approval from governing board before hire
     LVN
  - LEA must notify CDE and certify each year a diligent recruitment effort made to hire CSN; keep documentation of recruitment efforts



### **AB 1722 | Pupil Health**

#### Continued...

- LVN must be supervised by a CSN in same district or a CSN in another LEA
  - If supervision provided by another LEA, the two LEAs must have a written agreement regarding communication, indemnification, financial arrangement, & compensation of CSN
  - Does not allow LVN to do work beyond LVN legal scope of practice
- Clarifies who may test vision and hearing, including LVNs who are appropriately trained
- Changes vision appraisal to include test of far vision (instead of visual acuity)



#### SB 10 | Pupil Health

Opioid Overdose Prevention and Treatment: Melanie's Law Effective January 1, 2024 EC 32282

- For schools with any grades 7-12, the Comprehensive School Safety Plan (CSSP) shall include protocol for responding to a student opioid overdose
- CDE to post informational materials on opioid overdose prevention
- Encourages COEs to establish working groups on fentanyl education in schools



#### SB 323 | Comprehensive School Safety Plans

Individualized Safety Plans Effective January 1, 2024 EC 32282

- Requires Comprehensive School Safety Plans (CSSP) include adaptations for pupils with disabilities
- Requires annual evaluation of those plans to ensure appropriate adaptations
- Authorizes parents and others to bring a concern about a student's safety to the principal



#### SB 671 | School Safety Plans

Dangerous, Violent, or Unlawful Activities Effective January 1, 2024 EC 32282

- Requires Comprehensive School Safety Plans to include procedures to assess and respond to reports of any dangerous, violent, or unlawful activity that is being conducted or threatened to be conducted:
  - o at the school,
  - o an activity sponsored by the school, or
  - on a school bus serving the school

## AB 278 | High Schools

Dream Resource Center Grant Program
Effective January 1, 2024

EC 54680

- Establishes Dream Resource Center Grant Program
- Requires CDE to review applications /award grants
- Authorize a school district, COE, or charter school to apply
- Supplement, but not supplant existing Dream Resource Center
- On or before June 1, 2026, require the department to submit a report to the appropriate policy committees of the Legislature



#### **AB 1071 | Teen Dating Violence Education**

#### Online Information and Resources Effective January 1, 2024

EC 231.7

- Requires CDE to provide:
  - Resources on abuse, including sexual, emotional, and physical abuse, and teen dating violence prevention for professional learning purposes.
  - Information about local and national hotlines and services for youth experiencing teen dating violence,
  - Other relevant materials for parents, guardians, and other caretakers of pupils, available on its internet website.

#### **AB 95 | Pupil Nutrition**

Pupil Meals
Effective January 1, 2024

EC 49431 and 49431.2

- Schools may sell additional nutritiously adequate school meals to students who have already received their allotted free school meals as mandated.
- Provides flexibility for schools to offer supplementary meal options to students while maintaining the nutritional standards required for federal reimbursement.



### SB 348 | Pupil Meals

EC 49492, 49501.5, 49503, 49512, 49531, 49531.1, 49547.5, 49557.5, 49559, 49506, 41350, 47613.5, 49500, 49501, 49516, 49517, and 49550

Effective January 1, 2024

- LEAs participating in the National School Lunch Program and School Breakfast Program with students in grades Kindergarten to 12th grade must:
  - Provide breakfast and lunch on shortened days
  - Make available free of cost nutritionally adequate breakfast and lunch and allow adequate time to eat. CDE is tasked with making recommendations.
  - Maximize participation in the federal Summer Electronic Benefit Transfer for Children (Summer EBT)
  - Establish mealtimes and be allowed state meal reimbursement.
  - Provide meals for student participating in independent study when the student will be on campus two or more hours



### SB 348 | Pupil Meals

#### continued...

- Chartering authority shall provide technical assistance to the charter upon request to implement this law.
- Denial or delay of breakfast or lunch for a student under disciplinary action is not allowed.
- LEAs cannot take action against a student to collect school meal charge debt.



#### SB 291 | Pupil Rights

## Recess Effective July 1, 2024

EC 49056 and 44807.5

- School staff members <u>cannot</u> restrict a student's recess <u>unless</u> there is an immediate threat to the physical safety of the pupil or the physical safety of one or more of the student's peers.
- Recess time allotted:
  - At least 30 minutes on regular instructional days
  - At least 15 minutes on early release days, as provided and may be provided for one or more periods *unless* there is a field trip.
- Recess must be held outdoors whenever the weather and air quality permits. If outdoor space is not sufficient, permits recess to be held indoors.



#### SB 291 | Pupil Rights

#### Continued...

- Recess must comply with a student's individualized education program (IEP) or Section 504 Plan
- Requires that, *if* a student's recess period is denied, school staff members make all reasonable efforts to resolve such threats and minimize exclusion from recess and encourages school staff to implement other means of correction.
- These requirements *do not prohibit* a public school from providing students with snacks during recess



#### AB 800 | Workplace Readiness Week

#### Work Permits

EC 49110.5

#### Effective January 1, 2024

- LEAs will annually observe the week of April 28 as "Workplace Readiness Week"
  - Integrate "Rights of Workers" into 11th and 12th grade history-social science curriculum

#### Effective August 1, 2024

- A minor seeking the signature on the Statement of Intent to Employ a Minor and Request for a Work Permit-Certificate of Age to be issued, shall also be provided a document clearly explaining basic labor rights extended to workers.
- UC Berkeley Center for Labor Research and Education is encouraged to produce a draft template of the document which will include labor rights in plain, natural terminology, including translations into multiple languages.



### AB 889 | Pupil Safety

Parental Notification: Synthetic Drugs Effective January 1, 2024

- An LEA is required to annually inform parents or guardians of the dangers associated with using synthetic drugs
  - At the beginning of the first semester or quarter of the regular school term
- This information must also be posted via:
  - Annual notifications to parents
  - LEAs website



#### **AB 1165 | Pupil Discipline**

#### Racist Bullying, Harassment or Intimidation Effective January 1, 2024

EC 48900.5

- LEAs are encouraged to:
  - Have both the victim and perpetrator engage in a restorative justice practice, appropriate for the needs of both students, for a student who has been suspended or other means of correction have been utilized.
  - Regularly check on the victim of the racist bullying, harassment, or intimidation to ensure that the victim is not in danger of suffering from long-lasting mental health issues.
  - Require perpetrators to engage in culturally sensitive programs.



## AB 1503 | Pupil attendance SB 350 | Pupil attendance

#### Excused Absences | Religious Retreats

EC 48205

- Changed from *four hours per semester* for religious purposes to *one school day per semester*, *cumulative*
- Changed from "appearance" in court proceedings to add "attendance"
- Attending services changed *from one or three days* absence to *not more than five days* per funeral and *immediate family member* is defined.



#### AB 1605 | High Schools

Military Services: United States Space Force. EC 49603, 49701 Effective January 1, 2024

- "Military Services" definition includes the United States Army, the United States Navy, the United States Air Force, the United States Marine Corps, the United States Coast Guard, or any reserve component of those federal forces, the National Guard, the State Guard, and the active militia.
  - United States Space Force has been added to that definition.
- Schools that provide on-campus access to employers, cannot prohibit access to the military services.



### SB 274 | Suspensions and Expulsions

Willful Defiance: Interventions & Supports EC 48900 & 48901.1 Effective July 1, 2024

- Expands the prohibition of suspension of students from *Kindergarten to 12th grade* for 48900 (k) willful defiance, including charter schools
  - Sunsets July 1, 2029 for students 6th to 12th
- Reiterates use of other means of correction,
- Teachers may suspend from their classroom for EC 48900 (k) for the day of the suspension plus one.



#### SB 274 | Suspensions and Expulsions

#### Continued...

- LEA certificated and classified employees can refer students to school administrators for appropriate and timely in-school interventions or supports via other means of correction for *willful defiance*,
- School administrators are required to document other means of correction applied in the student's record within five business days.
- School administrators must inform the referring employee, verbally or in writing, what actions were taken or not, and why, by the 5th business day.
- Prohibits a suspension or expulsion from being imposed against a student based solely on the fact that the student is otherwise absent from school activities.



#### **SB 413 | School Attendance**

#### Interdistrict Attendance Effective January 1, 2024

EC 46601

- Currently, a county board of education in a class 1 or class 2 county has 30 calendar days to complete the interdistrict appeal process.
- This law extends the timeline to 60 calendar days if:
  - There is a delayed response by the parent, guardian, educational rights holder, or school district.
  - Incompatible availability for the fact finding hearing for all parties.
  - The parent, guardian, or educational rights holder request to delay a fact finding hearing or board hearing or is unable to attend a fact finding hearing or board hearing.
  - The school district has closed their annual application window and is no longer accepting permit applications for the remainder of the current or future school year.



### SB 760 | School Facilities

#### All-Gender Restrooms Effective July 1, 2026

EC 35292.5 and 17585

- A restroom to be temporarily closed as necessary for a documented pupil safety concern, an immediate threat to student safety, or to repair the facility.
- All LEAs with grade one to twelve, must provide and maintain at least one all-gender restroom for voluntary student use at each of its schoolsites.
- The all-gender restroom must have signage identifying the bathroom facility as being open to all genders and is unlocked, unobstructed, and easily accessible by any student.



#### **SB 760 | School Facilities**

#### Continued...

- An LEA staff member shall be designated as a point of contact and a notice regarding these requirements shall be posted in a prominent and conspicuous location outside at least one allgender restroom.
- An existing restroom may be used to satisfy these requirements.
- The CDE is required to post on its internet website guidance for implementation of these provisions.
- Any LEA applying on or after July 1, 2026, for Greene Act school modernization project must include an all-gender restroom designed exclusively for students to use.

# AB 368 | College & Career Access Pathways (CCAP) Partnerships

#### Effective: July 1, 2024

EC 76004

- Clarifies and defines students who are "underrepresented in higher education" as:
  - First-time college students
  - Low-income
  - Current or former foster youth
  - Experiencing homelessness or at risk of being homeless
  - Students with disabilities
  - Students with dependent children
  - Undocumented
- Exempts fee requirements for all students seeking to enroll in a community college course that is required for the students' CCAP partnership program
- Prioritizes registration for students who participate in CCAP courses regardless of where the course is being offered.
- Updates the reporting requirements for CCAP partnerships

# **AB 373 | Intersession Programs**

Foster Children and Homeless Youth: Priority Access

Effective January 1, 2024

EC 48850 and 48853.5

- Summary: Would require any LEA that operates an intersession program to grant priority access to youth in foster care and children & youth experiencing homelessness.
- ESY remains under the auspices of the student's IEP.
- Includes summer school and allows the education rights holder to determine school site if student is moving during intersession. *Unaccompanied youth can determine their school site to attend*.



## **AB 723 | Pupil Placement**

Special Education: Foster Children: Non-Public, Nonsectarian

Schools or Agencies: School of Origin.

Effective: July 1, 2024 EC 48853.5, 56366.1, and 56366.10

- Summary: Would require a nonpublic, nonsectarian (NPS) to be considered the school of origin for a student in foster care with exceptional needs. The NPS would have to agree that the program would become the student's school of origin.
- Will commence the 2024-25 school year.



# Driver Qualifications Effective: July 1, 2025

EC 49406 and 397875

- Summary: New requirements on drivers, whether employed by or contracted by a local educational agency (LEA), who provide transportation services to students for **compensation**.
- School related student transportation is defined in E.C. 39881 as:
  - home-to-school transportation
  - field trips
  - o after school program-related transportation
  - preschool and childcare-related transportation
  - athletic program-related transportation
  - extracurricular school activity-related transportation or
  - any transportation of pupils to or from a school campus.



#### Continued...

- Specifically, drivers who transport students in a vehicle with a maximum capacity of 10 or fewer persons, are required to...
  - complete a criminal background check, including fingerprint clearance;
  - have a satisfactory driving record;
  - comply with drug and alcohol test requirements;
  - submit and clearing a tuberculosis risk assessment;
  - maintain a daily log sheet and completing a daily pre-trip inspection of the vehicle; and
  - o complete training at least the equivalent to the American Red Cross first aid training program; *and other various requirements*



#### Continued...

- Requires that any vehicle used to provide student transportation for the compensation be inspected every 12 months of every 50,000 miles, pass inspections, and be equipped with a *first aid kit* and *fire extinguisher*.
- Exempts parents and relative who drive their own children, a school employees who provide transportation to pupils they supervise, and other government or foster care agencies providing services to youth in foster care or experiencing homelessness.
- The bill specifies that to the extent this bill's requirements conflict with a contract entered into before January 1, 2024, this article will not apply until the expiration or renewal of the contract.



#### Continued...

#### E.C. 39875

- This *does not* apply to a driver who transports a student if the transportation if being provided through a Foster Youth Services Coordinating Program while a pupil's transportation plan is being finalized. The exemption shall apply for a period lasting no longer than one month after the first ride is provided to that pupil under this exemption.
- This *does not* apply to a driver during a trip for which they are authorized by the LEA to transport one or more pupils for a field trip when the destination is more than 200 miles from the transported pupil's California School campus.

### AB 10 | Pupil

Body Shaming Model Policy and Resources Effective: On or before June 30, 2025

EC 232.7

CDE must develop and post on its website a model policy and resources about body shaming.

- Body shaming means the action or practice of mocking or stigmatizing a person by making critical comments or
- observations about the shape, size, or appearance of the person's body.

### District Responsibilities:

School districts, county offices of education, and charter schools are encouraged to inform teachers, staff, parents, and pupils about the resources once posted on the website.



### **AB 289 | Mental Health Services**

Representation
Effective January 1, 2024

WIC 5848

#### Updates Prop 63, Mental Health Services Act

- Requires counties to include participation of individuals representing diverse viewpoints in the development of the county Mental Health Services Fund 3-year program and expenditure plan, and annual updates.
  - O Representatives include: education agencies, youth from historically marginalized communities, organizations specializing in working with underserved racially and ethnically diverse communities, and LGBTQ+ communities.
  - O Counties partnerships must reflect meaningful stakeholder involvement on mental health policy, program planning, implementation, monitoring, quality improvement, evaluation, and budget allocations.
  - O A draft plan and update shall be prepared and circulated for review and comment for at least 30 days to parties who have requested a copy.



## AB 665 | Minors

### Consent to Mental Health Services Effective: July 1, 2024

FC 6924

- Aligns existing laws authorizing minors 12 years of age and older to consent to mental health treatment or counseling on an outpatient basis, or to residential shelter services, by:
  - o **Removes requirement** that the minor present a danger of serious physical or mental harm to themselves or to others, or be the alleged victim of incest or child abuse,
  - o **Required professional person** treating or counseling the minor to consult with the minor before determining whether involvement of the minor's parent or guardian would be inappropriate, and by
  - Adds to definition of professional persons: a registered psychologist, a registered psychological assistant, a psychological trainee, an associate clinical social worker, a social work intern, a clinical counselor trainee working under the supervision of a licensed professional, and a boardcertified psychiatrist.



## **AB 1173 | College and Career Fairs**

### Effective Date: January 1, 2024

EC 52770

- Requires LEAs (grades 9-12) to notify each community college district that has an overlapping jurisdiction with the LEA of planned college and career fairs and to provide an opportunity for the community college district to participate in the event.
  - Notice shall be delivered to the community college district before the planned event by first class mail or email.
    - Include both of the following:
      - Planned and time of the college or career fair
      - Planned location of the college or career fair

### **AB 275 (Ward)** –

School governance: governing boards: pupil members: compensation.






#### Interdistrict Attendance



**SB 413** (**Bradford**) – Requires county boards of education (CBE) to decide interdistrict appeals within 30 calendar days and authorizes a class 1 and 2 CBE counties to decide interdistrict appeals within 60 calendar days in instances that involve delays and scheduling conflicts initiated by the parent or home school district; and in cases where the application was filed outside the home school district transfer window.
























### Early Childhood Education



**AB 555** (Carrillo) – Increases access and expand opportunities for children in the California State Preschool Program (CSPP) by removing barriers that programs face in serving three-year olds.

**AB 596** (**Reyes**)/**SB 380** (**Limón**) – Requires the development of an alternative methodology for calculating subsidy payment rates for childcare and development services using a cost estimation model.







AB 5 (Zbur) – Requires the development of an online training delivery platform and online training curriculum to support LGBTQ+ cultural competency training for teachers and certificated employees.

AB 368 (Holden) – Requires community colleges, who participate in College and Career Access Pathways (CCAP) partnerships to provide priority registration for participating high school students.

SB 274 (Skinner) – Prohibits the suspension or expulsion of a student enrolled in 6th through 12th grade in a public school on the basis of willful defiance until July 1, 2029.



### **Hot Bills**



**AB 1078 (Jackson)** – Prohibits a governing board from disallowing the use of an existing textbook, other instructional material, or curriculum that contains inclusive and diverse perspectives.

AB 1699 (McCarty) – Would have provided current nonprobationary school and community college classified employees the right of first refusal for any new classified position at their education employer.

**SB 88 (Skinner)** – Requires drivers who provide transportation services for pupils to submit and clear tuberculosis risk assessments, and require any vehicle used to provide pupil transportation for compensation by a local educational agency to be inspected and equipped with a first aid kit and a fire extinguisher.



### **Executive Orders**

#### **Career Education –**

Prepare students and adults for the workforce of tomorrow and directing additional steps to reduce employment barriers for state jobs.

### **Artificial Intelligence** –

Outlines the state's opportunities to use Generative Artificial Intelligence (GenAI) while highlighting potential harms.

# Proposition 1: The Behavioral Health Infrastructure Bond Act of 2023


Authorizes \$6.38 billion in general obligation bonds to finance loans or grants for various purposes, including the conversion, rehabilitation, or construction of permanent supportive housing for homeless veterans and others meeting specific criteria, as well as grants for the Behavioral Health Continuum Infrastructure Program.


