Welcome to the New Year!

I'd like to pat every CWA person on the back, throughout our big state, for all the diligent work and attention you've given to addressing and resolving some of the serious issues that face us today. Student discipline and expulsions, safe schools, procedures for choice" intradistrict and interdistricts transfer permits.

After receiving a letter from a parent, questioning the new "Open Enrollment Policy". I realized that the actual implementation of such a

policy, would at the minimum,

be a nightmare. Here's a copy of that letter:

Dear Child Welfare and Attendance

As a parent of three Clovis Unified students. I received your letter of November 1, 11994 regarding open enrollment policy. The letter states that the selection of students "is made through a random, unbiased process. ." The letter goes on to state, however, that the District will consider a student's race or ethnicity before approving an application.

Your letter further explains that the District will maintain "appropriate raciall and ethnic balances" and create boundary lines to create "an equitable balance of all cultural background represented by the District." Further, prior to approval of a transfer, the principal of the school of residence will provide and the principal at the selected school will review racial and ethnic infomation on all applications fortransfers.

Please inform me, in writing, how the District can be unbiased and yet make race and ethnicity specific factors to be considered before an application will be approved. Additionally, what particular races and ethnicities will the District consider in the application process? Third, please explain what is an "appropriate" or "equitable" balance of race and ethnicity for each school. Finally, please explain to me why any child must provide his or her ethnicity or race to the District, a public entity, for the District's review.

Very truly yours.

Wow! See what I mean? Of course these questions were immediately referred to our state's ever "reliable and ready", Jean Stovall, for an appropriate response.


Personally, I hadn't taken enough math in college to come up with the correct equation to make all the deductions, nor had I brushed up on my philosophy background in order to articulate the answer.

BAY SECTION HOSTS PANEL ON PROPOSITION 187

Recently, an article was published in our local newspaper about teenagers who have basically raised themselves. Despite deplorable living conditions. they managed to survive and to excel in school. In one case, a teenage girl was removed from her home and placed in foster care. She stated that although basic needs were met, her basic human rights were ignored. The human touch was nonexistent, and no one seemed to take any personal interest in her.

Her life began to stabilize only after she had worked with three counselors who displayed compassion and concern for her general welfare. These few adults helped to change the direction and perception of this individual simply because they genuinely cared and took the initiative to become involved. Because of the positive impact these adults had on the development of her sense of self-worth and sense of competence, she was proud to report that she is a high school graduate and has overcome the difficulties of a broken home. The purpose and vision the Bay Section conference committee had in mind as we planned conference events, focused upon resiliency factors that produce positive change in our youth. The student mentioned is just one illustration of a deprived student whose perspective changed when she was empowered and encouraged. Like many others, young people can resist negative pressures once they experience a sense of competence and sense of control over their lives. Research shows this statement to be a fact. Our conference goal was to address resiliency issues that affect youth, to select presenters who could discuss resilient behaviors and to offer programs that encourage positive change.

Thanks to the cooperation of the School Law Enforcement Partnership CADRE, Western Regional Center for Drug-free Schools, and Communities, ACSA, Bay Region IV Healthy Kids Center, Garrison Associates and the National Training Associates we featured well informed presenters. They were exceptionally effective in providing conference participants with positive, researched based approaches that promote resiliency prevention and intervention We received many strategies. It was a great conference with enthusiastic responses.

Bay Section's executive board met last month to critique the conference, discuss changes and make recommendations for future conferences. Also, we planned meetings and activities for the winter and spring of the 1994-5 school year. Executive board and luncheon meetings will occur on the following dates: January 13, March 10 and June 2, 1995. The January meeting will be held at the San Leandro Public Library. Lee Lundberg will moderate a panel discussion that will address interpretations, perceptions and the impact SB187 will have on schools throughout the State of California. Panel members will include: Emi Johnson, Special Education Director, Berkeley Unified School District, Katie Curry, Chair, ACCA Legislative Policy Committee, and Ralph Stern, Attorney for Alameda County Schools.

Over the past year and a half. Shirley Kesterke has

been working closely with the Fremont Police Department, district attorney, and municipal judges to prosecute parents for their student's truancy. Last year nine parents were fined from \$100.00 to \$500.00. One parent received a deferred sentence. This parent was required to meet several requirements, one of which included verification of attendance to eight consecutive parenting classes.

The Fremont Police Department has issued a training bulletin to all officers requesting that they assist Shirley in her efforts to enforce truancy laws. She has provided the schools with written procedures to follow when students are returned to their respective schools. Thanks, Shirley, for all of your hard work.

We are continuing to pursue an active recruiting program. Budget cuts throughout the state have forced many school districts to eliminate counselors. As a result, assistant principals have had to assume all pupil service responsibilities. We have decided to target this group for membership in our organization, since there is obviously a great need for all assistant principal's to associate with CASCWA

Senate Bill 592, Chapter 98, Russell, was passed by the California Legislature, signed by the governor and became effective immediately on June 6, 1994. The bill authorizes an adult caregiver (1 8 years of age or older) to enroll a minor in school and consent to school related medical care.

In view of the numerous local school district and Education Code requirements for proof of residency and guardianship status, the new caregiver legislation has brought about a number of

concerns for some school administrators. Let's take a look at some of those concerns.

Adolescents and teens living with adult boy friendslgirl friends with or without the consent of parents.

The new legislation does not in any way affect the responsibility of the school administrator to report to Children's Protective Services (C.P.S.) any and all situations in which we have reason to believe that the minor may be in danger. Caregivers are not excepted. Making such reports and conducting investigations (by C.P.S.) would put an immediate stop to any such inappropriate living arrangements when it is determined that the situation is not in the best interest of the minor. In the meantime, the minor is in school

and because of his or her enrollment we are able to intervene.

Several pupils living with and adult who is known to be involved in gang activities.

Here again, the living arrangements may be suspect by the school administrator as not being in the best interest of the minor. Such cases should be reported to C.P.S. A foster home license could be required. Additionally, the caregiver could be subject to a fine or imprisonment if it is determined that the information provided was incorrect.

The new provisions are being used to circumvent the Immigration and Naturalization Services requirements.

When such situations are expected, it should be reported to the immigration authorities. Minors may be subject to deportation in as much as the pupil is not a resident and has come into the country for the sole purpose of going to school, free of tuition costs. In situations where schools receive information indicating that several non-related minors may be living at the same address, it is again the responsibility of school officials to report such situations to C.P.S.

Pupils with special needs are brought in for the sole purpose of enrolling in a select district.

Caregivers, just as foster parents, do not have authority to act on behalf of the minor in decisions relative to the Individual Education Program (I.E.P.). A surrogate parent or the natural parent or guardian must be brought in for such matters. Each school district is required to have a policy and procedure for the training and assignment of surrogate parents.

These are but a few of the concerns raised relative to caregivers enrolling pupils in school. As one can see, there is already in place, mechanisms to address many of the caregiver concerns. In the meantime, the pupils are much better off enrolled and attending school rather than living in an inappropriate situation that is not brought to the attention of a responsible adult.


In retrospect, it may be helpful to reflect upon what has brought about the need for caregiver legislation. We are seeing increasing numbers of children who are neither living with a parent, guardian or relative. Many school districts (notice, I did not say all) have been reluctant to enroll these pupils in the absence of a parent or guardian. Through no fault of their own, these children have been cut off from family, friends, and even schools. SB 592. was written for the sole purpose of helping to get these children enrolled in school

Remember, no matter how much we try to do in the best interest of children, there will always be someone who will try and take advantage of the system.

As of this writing, a follow-up Department of Education Management Advisory is in progress and will help to clarify some of the issues and concerns being raised about caregiver implementation. New legislation may be introduced if it is determined that present statutory authority is not sufficient to address problems as they arise. In the meantime, it would be in the best interest of children to precede with minimal jitters, thorough recapitulation of what is already on the books, and total involvement of all systems that impact upon meeting the needs of children.
