

**OUR MISSION** 

For those of you who will not be attending the spring conference in Fresno, this column will serve as my Swan Song as CASCWA State President. I would like to share with you a few the accomplishments of the State Executive Board this year.

In the September Intercom I wrote that my charge to the Executive Board was "to explore our organizational purpose and structure and to revision the future of our

organization." Inevitably, the charge lead us to revisiting and re-articulating the CASCWA mission and purpose. I believe the re-articulated mission statement is special not because of any eloquence of language, but because it reflects what we are as much as our aspirations Many mission or purpose statements fail to ring true because the organization and membership don't walk the talk. My experience in CASCWA, which has spanned the better part of three decades, is that CASCWA members support each other and are serious stewards of their profession. Since many of us are lone wolves in our organizations, we depend on CASCWA for the camaraderie of peers and affirmation of the unique view of education and child advocacy we experience as a consequence of Welfare and Attendance Child performing Services. In this sense our organization is inclusive, purposeful, an inner circle. On the other hand, our work and professional experience demand that we share and impact other educators and service professionals on behalf of children and families. Historically we have encouraged and participated in systemic change. These are not things we WISH TO DO, they are what we do and WHO WE ARE. Our shared professional purpose demands of us that we constantly reinvent ourselves and challenge our views and collective vision. Our professional fellowship is vital to this It is the hope of the Board that this statement captures the spirit and the collective purpose of our membership:

The California Association of Supervisors of Child Welfare and Attendance is a community of unique school professionals and staff who have joined for the common purpose of:

Creating a network of mutual support and professional growth
Working to impact legislatiuon and policies relating to minors; and
Advocating for children

OUR COLLEAGUE

You may know some CWA worker who best personifies the spirit of our mission statement. I have a handful that come to mind but no one more than my friend and CWA mentor, Lee Lundberg. Lee and John Burton were instrumental to my involvement in Child Welfare and Attendance. Sometimes Lee is a one man marketer and promoter of CASCWA and he has been the major instrument of our legislative efforts. Based on the number of calls I have received, I am sure most of you are aware that Lee has been diagnosed as having cancer and he is now focused on recovery. As of this writing, Lee has started chemotherapy. He is his resilient self and demonstrates the realistic optimism which is so characteristic of him. He wishes to thank you for the many cards, flowers, phone messages and prayers which left his resolve.

OUR LEGISLATIVE EFFORTS

In Lee's absence I would like to share with you our progress in the area of addressing our organization's concerns regarding caregiver affidavits (SB 592 Russell). The CASCWA Executive Board has set addressing abuses associated with caregiver affidavits, interdistrict transfers, and residence as an area of major legislative effort. Representatives from CASCWA, including Lee Lundberg, myself, Phil Kauble, Hector Madrigal and Mike Parks have been meeting with Tom Bancroft of ACSA and others to sponsor comprehensive legislation in these related areas. The legislation will continue protection of student access and address misuse by caregivers and districts. While actual abuses of caregiver affidavits varies greatly in the state's districts, there is shared concern regarding the larger picture of statutes governing student registration which invite abuse and fail to adequately protect children and districts from unfair financial burdens.

Some of the notions which are being discussed include:

√The need to continue protection of student access - students need to be in school and enrollment delays need to be minimized.

✓Prevent system bouncing - applicants who fail to get an interdistrict try Allen Bill residency then caregiver affidavit ...

✓Institute a resolution or due process appeal for caregiver disputes.

✓ Keep records of reasons for enrollment with caregiver affidavits (Reason later proves invalid, enrollment can be revoked).

✓Allow caregiver to provide permission for ordinary school functions.

✓Define situation(s) in which districts may refuse affidavits.

✓Amend law to allow districts to not accept caregiver affidavits if previous falsification has occurred.

- Establish in statute, or CDE advisory, protocols for obtaining guardian and other directory information consistent with the child's welfare and safety.
- Require caregiver to sign affidavit in presence of designated school official.
- I look forward to seeing you in Fresno in a few weeks

### NEW LAWS AND SOME STILL IN PROCESS FROM THE LEGISLATIVE COMMITTEE

Despite Lee's temporary absence, the Legislative Committee has been just as active as ever. Listed below are the laws that will soon be in effect, and thereafter a list of two year bills with CASCWA's current committee position. Remember, the text of all bills is available from the Legislative Bill Room. Call (916) 445-2323. The material on this page is as of February 28, 1996

This bill will reauthorize a school district that participates in school-based program coordination to establish an alternative education and work center for school dropouts at a continuation high school or adult school or to contract with a private organization to provide the center. Also, this bill would reestablish educational clinics that would recruit or receive referral of high school dropouts.

AB 922 Friedman Chapter 974
This bill will require the governing board of a school district, at the time an expulsion of a pupil is ordered, to ensure that an educational program is provided to the expelled pupil for the period of time of the expulsion.

CHAPTERED BILLS
Hawkins Chapt

AB 49 Hawkins

This bill will require the governing board of the school district to set a date of one year from the day of date expulsion occurred when a pupil expelled for possessing a firearm may apply for readmission.

AB 14

This bill will require the superintendent of schools of a county that does not maintain a community school to develop a plan with the governing board of the school districts in that county to ensure that pupils in that sound, who need an alternative school placement are served.

AB 265 Alpert Chapter 377
This bill will define the minimum school day for pupils attending county community schools as 4 hours of classroom instruction and 60 minutes of immediately supervised attendance, excluding the lunch period. It would also permit a pupil enrolled in a county community school to be assigned to an instructor supervised education program consisting of 20 contract hours of independent study plus a minimum of 5 hours of immediate supervision and would limit the use of independent study in community schools.

AB 618 Morrow Chapter 937

This bill will authorize before an expulsion hearing the governing board of the school district to issue subpoenas for the personal appearance of percipient witnesses at the request of the superintendent of schools or the superintendents' designee of the pupil.

This bill will enact the Gun-Free School Zone Act of 1995. This bill would require imprisonment of 2, 3, or 5 years if a person possesses a firearm in, or on the grounds of a K12 public or private school or within 1000 feet from the school.

AB 1344 Sweeney Chapter 163

Existing law makes it a misdemeanor for any person to reenter upon the campus or facility of any public school, college, or university if the person willfully and knowingly does so within 7 Chapter 973 Delay after being directed to leave under specified any bard of the eyear from the conditions.
