FACILITATING THE INTERDISTRICT TRANSFER AND EXPULSION APPEAL PROCESS

Submitted by Sherman R. Garnett, Coordinator, Child Welfare and Attendance, San Bernardino County Superintendent of Schools

During November, 1998, San Bernardino County Assistant Superintendent Julian Weaver and I were summoned to the Office of the San Bernardino County Superintendent of Schools, Dr. Barry Puliam.

The purpose of the meeting was to discuss ways/methods to reduce the number of Interdistrict transfer and expulsion appeals filed with the County office. Having just accepted the position as Coordinator of Child Welfare and Attendance one-week earlier and having the supervision of my position placed under a different assistant superintendent than my predecessor, I was unaware of the concern raised by the Superintendent.

Superintendent Puliam explained to us that an inordinate amount of time was being spent by the County Board hearing appeals that could have been resolved without a hearing. Additionally, local school district personnel were spending valuable personnel hours and funds providing materials to the County Board such as hearing transcripts and other necessary documents. He requested that we research the issue and present a plan to the San Bernardino County Board of Education the following month relative to his concerns.

After researching all interdistrict transfer and expulsion appeal cases filed with the County Board for the previous three years, the following issues surfaced:

- Many Interdistrict transfer appeals could have been resolved without the benefit of an appeal hearing.
- Many expulsion appeals could have been resolved without the benefit of an appeal hearing.
- There were several cases of no-shows by the appellants for expulsion appeals.
- Upon filing of an Interdistrict transfer or expulsion appeal, there was no interim process prior to the actual Board hearing.

Working with this information, Assistant Superintendent Weaver and I organized a committee to address the issues. As a result of the successful committee collaboration, I presented to the County Board for approval the following plan:

- A. Development of user-friendly handbooks for Interdistrict transfer and expulsion appeals. The handbooks are based upon current education code outlining the process and responsibilities of parents and districts. The handbooks are automatically distributed to parents upon initial inquiry of an interdistrict transfer appeal or expulsion appeal.
- B. Assignment of a Facilitator to file Interdistrict trans

fer and expulsion appeals. Upon formal filing of either appeal, a facilitator is assigned to the case by the Coordinator of Child Welfare and Attendance. The purpose of the facilitator is to notify the district of the appeal filing, assist the parent in securing necessary documents to provide to the Board during the interim process and serve as an active listener, have weekly contact with the parent in regards to questions regarding the process, etc., while remaining neutral.

- C. In-service local school district personnel of the County schools office's role and County Board policy related to Interdistrict transfer appeals and expulsion appeals.
- Update current suspension, expulsion and due process handbook.

The County School Board unanimously accepted our recommendations. During the next two months, my office vigorously trained local district personnel, staff and facilitators. As a result of this process, the following has occurred:

- The numbers of Interdistrict transfer appeals heard by the County Board have been reduced 75% in one year
- The numbers of expulsions heard by the County Board have been reduced 48% in one year.

Parents and school districts have expressed overwhelming satisfaction in the usage and effectiveness of a facilitator during the interim process.

SAMPLE PROCESS

Listed below is a sample process used by the San Bernardino County Office of Education in the area of Interdistrict transfer appeals and expulsion appeals:

- Office receives phone call or letter stating an intent/ inquiry to the appeal process.
- Parent is sent, via U.S. mail, a packet of information, which includes an appeal handbook and appeal form.
- Coordinator, Child Welfare and Attendance assigns the case to a facilitator.
- Facilitator meets/contacts appellant. Explains process. Assists with delivery of materials to County Board. Additionally, Facilitator notifies school district of parent's appeal.
- E. Facilitator reviews case with Coordinator, Child Welfare and Attendance.
- F. Facilitator observes appeal hearing.

The Interdistrict transfer and expulsion appeal process continues to serve a vital role to school districts and parents. My office is currently reviewing and updating manuals created to further assist all. If you desire a copy of either handbook, please do not hesitate to contact me at:

KNIVES: ARE THE LAWS CONFUSING?

It is 3:00 PM in the afternoon. You are about to meet with a family of a student who has brought a pocket knife to school. You have read the written documentation and you have discussed the situation with the school site administrators. You take a minute to review California Education Code 48915. This code basically states that the Principal or Superintendent shall recommend an expulsion of a pupil who has possession of any knife, explosive or any other dangerous object of no reasonable use to the pupil.

At that point in time, you know that this student has admitted to being in possession of a knife and you believe that the matter is not being disputed in any manner, shape or form.

You carefully turn over the document packet and focus your eyes on the page that shows a xerox copy of the knife. The xerox shows a knife sitting next to a ruler on the page. It is at this moment that you realize you are dealing with a small "Swiss Army" knife that has a blade length of I I/2" and a handle length of 2 1/4". It is not a very large knife.

You hear a knock on the door and in walks the family and their attorney. Based on previous conversations of this kind, you realize that the majority of attorneys are knowledgeable of due process, trails of evidence, and procedures. However, past experiences have shown that many attorneys have not had a great deal of experience dealing with education codes and school district hearings.

Within a few minutes, the attorney points out to you that in Section 48915 (g) there is a definition of a knife. The definition says, "...knife means any dirk, dagger, or other weapon with a fixed, sharpened blade fitted primarily for stabbing, a weapon with a blade longer than 3 1/2", a folding knife with a blade that locks into place, or a razor with an unguarded blade."

At this point in time, you scratch your head and listen to what is coming next. The attorney then shares with you Penal Code 626.10. This Penal Code refers to dirks, daggers and knives and makes reference to a violation for possessing a knife with a blade of 2 1/2" or longer in length. Once again,

the attorney points out that his client's knife is a small "Swiss Army" knife.

To compound this matter, the attorney makes reference to Penal Code 653 (k) which makes reference to a switch blade knife which designates a misdemeanor offense for any knife with a blade longer than 2". The attorney looks across the table and has one more simple question, "Isn't it true that since this knife is not a locking blade and is less than 2 1/2", the district isn't even completing a State of California Crime and Violence Report?"

You look across the table and realize that once again you are placed in a position of having to explain to the attorney and his clients the range of laws pertaining to knives. You start with the law that states, "a knife of any kind" and work your way to "a knife with a 3 1/2" long blade".

You would prefer to be dealing with a dirk, bayonet, locking blade knife, or maybe even a machete for the purpose of your meeting, but you realize once again that you are dealing with a small "Swiss Army" knife.

In the middle of this meeting, the conversation gets very quiet and you have an opportunity to speak your mind, represent your school district, and to take appropriate measures.

You look across the table and you proceed to tell the family about the worst incident involving a knife that you have experienced. You remember the day that two friends were goofing around in a band class. One of the friends opens up a small "Swiss Army" knife and walks up to his friend from behind. He then gently pokes his friend in the middle of the back from behind with the open blade. He is doing this in a joking manner. However, his friend jumps and spins around and the knife cuts into him the length of his arm and into his hand. The accident resulted in over 100 stitches, two operations to repair ligaments, and trauma to the families involved.

You think back to that day when you vowed you would do everything you could to keep your schools safe. You tell the parents and the attorney that knives do represent a danger. They are considered a dangerous object under Education Code 48900 (b) and that any student carrying a knife must be considered a potential threat. They have no business being in our school. You then take the time to share with the attorney and the family all of the codes that have been discussed. You reflect upon your school board

policies and administrative procedures that are in place in your school district. It is your responsibility to enforce the consequences of the student's violation as outlined in the disciplinary guidelines.

For the majority of the districts, passive possession of a knife could result in either an "Expulsion" from the school district or a "Suspended Expulsion" with terms and conditions determined by the school district and approved by the board of education. Of course, the evidence supporting the finding of the facts will have to prove either (1) that other means of correction are not feasible or have repeatedly failed to bring about proper conduct, or (2) that due to the nature of the violation, the presence of the pupil causes a continuing danger to the physical safety of the pupil or others.

You inform the family and the attorney of the hearing process. You work with the family for an appropriate placement and begin the process of developing a rehabilitation plan. Everyone shakes hands, they understand what's going on, and there is a true sense of reality that everyone is working for the best interest of the student and, hopefully, to promote school safety. The family and the attorney leave and you draft the letter notifying the family of the date, time, and place for the expulsion hearing.

You sit in your office and once again ponder, why? Why is it that these laws need to be so confusing? Why is it that you need a ruler to call a knife a knife? You carefully reflect upon the pending hearing and the child who has been in your office. You know that within a few days or weeks this process will be repeated with a new family, a new attorney, and a different school.
