Southern Section Scholarship Information The Lillie Wilson Scholarship Program 2004 Patricia James, Scholarship Chairperson

The California Association of Supervisors of Child Welfare and Attendance (CASCWA) annually awards scholarships to deserving students who have made a significant change in their academic and personal lives due to the efforts of a Child Welfare and Attendance (CWA) professional. The scholarships are named after Lillie Wilson, a legend in the field of Child Welfare and Attendance. She is now retired after serving the children in the State of California with outstanding decades of inspirational service as a nurse and as an administrator with the Los Angeles County Office of Education. She has left her mark on our profession and we are honored to associate our scholarship awards with her name and legacy.

CASCWA commends and congratulates Martha P., Kimberly S. and Christina P., recipients of the 2003-2004 CASCWA Southern Section, Lillie V. Wilson Scholarship for demonstrating strength, determination, and perseverance while overcoming adverse situations. We celebrate these young ladies for their efforts and accomplishments with a Scholarship Award in the amount of \$500 towards a continued pursuit of their educational goals. Their inspirational stories set forth the positive, reinforcing message that troubled teens are capable of turning their lives around and fulfilling their dreams.

Martha P. whose combative behavior and absenteeism led to probationary status with the courts and a placement at the Chino Valley Learning Academy, a Community Day School, successfully completed the required coursework and even managed to graduate a year early; a feat made more



difficult considering that Martha is also a single teen mother, adding more responsibility to her young life. Through a cooperative support system consisting of her mother, instructors, and principal, Martha managed to stay on track and attain her goal- that is, "to be the first one in her family to graduate." Martha's future goals are to attend college so as to pursue a career as a probation officer. Her purpose is to help guide students who are faced with difficult situations. She is also intent on succeeding for the sake of herself, her son, and "to make her mother proud." Martha was nominated for a scholarship by CASCWA member Roberto Casas from Chino Unified School District.

Kimberly's obstacles stem from a lack of self-motivation, which led to excessive absences and credit deficiencies. Due to her poor attendance. Kimberly was referred to SARB and subsequently placed on probation. As a result of a life-changing event, the



loss of her mother, Kimberly came to the realization that she "needed to get her head on her shoulder." Having been sent to an alternative school, Kimberly began to attend school on a daily basis and complete her assigned work, making her eligible for graduation. Kimberly plans to attend Community College after high school. Her dream is to one day open her own day care center where she will have a positive impact on youth lives. Kimberly was nominated for a scholarship by CASCWA member Elaine Anderson from Vista Unified School District.

Christina is also a teen mother who has had to grow up quickly for the sake of her child's welfare. During this time in her life, Christina made ill-advised decisions. Her attendance and academics suffered. Christina credits the District Attorney's intervention for "turning her life around for the better." Christina managed not only to graduate a year early, but also with honorable mention. Christina will attend Chaffey Community College where she will take general education courses while she decides on a major. Her goal is to transfer to a university to attain a bachelor's degree. Christina was nominated for a scholarship by CASCWA member Sherman Garnett, San Bernardino County Office of Education.

Each young lady has had to traverse difficult situations and each has demonstrated the ability to visualize and bring to fruition their objectives. To Martha, Kimberly, and Christina, we wish continued success and applaud their achievements.

CASCWA Southern Section "Constitution and By Laws" Proposed Revisions

The CASCWA Southern Section Board of Directors has undertaken the task of revising the Constitution and Bylaws. The last revision took place in May 1995 and several organizational changes have occurred since that time that need to be incorporated into the document. The proposed revisions appear as follows in this issue. Please take a few minutes to review the proposal and then cast your ballot, Southern Section only, to enable the Board to complete the process. As stated in Article X, the amendments to the document require approval of the majority of the membership.

Several changes were editorial in nature only, i.e. grammatical corrections, incorrect spellings, and do not require approval. You will note that strikethrough appears in current language to be revised while new language appears in **bold print**. It should also be noted that the Board is proposing to operate under Constitution only, rather than Constitution and Bylaws. It is not necessary to have both and in the interest of clarity, it was decided to use Constitution by itself.

ARTICLE I	Name of the Organization

ARTICLE II	Authority

ARTICLE III	Purpose

ARTICLE IV	Objectives

- The California Association of Supervisors of Child Welfare and Attendance, Southern Section shall:
 - Identify and disseminate information to all members that will be helpful to them in the performance of their duties. (This information may be provided through a newsletter or by other means.)
 - B. Promote the development of programs that will improve student attendance.
 - C. Promote the development of a unified, all inter-agency approach, in order to work with students in the community.
 - D. Promote the development of guidance and counseling programs to meet the needs of students.

- E. Participate in the development of curricular programs, which are attractive to students and thereby motivate young people to remain in school.
- F. Advocate and assist in the development and maintenance of student records in the schools and community.
- G. Develop and promote legislation that will improve services to students and members of the Association.
- H. Work with employers, labor commissioners, and others to improve services to employed students.
- Create an awareness among school personnel, students, families and communities, of the functions performed by Child Welfare and Attendance personnel.

ARTICLE V Organization and Membership

Section 1

The Southern Section of the California Association of Supervisors of Child Welfare and Attendance is composed of the following geographical areas.

Area I San Diego County

Area II Riverside, San Bernardino and Imperial Counties

Area III Los Angeles Unified School District

Area IV All of the Los Angeles County, except Los Angeles Unified School District

Area V Orange County and Long Beach Unified School District

Area VI Ventura, Santa Barbara, San Luis Obispo and Kern Counties

Area I Coastal/Kern (Ventura, Santa Barbara, San Luis Obispo and Kern County

Area II Los Angeles County, except Los Angeles Unified School District

Area III Los Angeles Unified School District

Area IV Inland (Riverside, San Bernardino and Imperial Counties)

Area V Orange County Area VI San Diego County

Section 2

Active membership in the Association shall be limited to individuals presently employed or actively in pursuit of a career in the public schools of California in the fields of Child Welfare and Attendance, city, district, and county, superintendents of schools, and to other leadership personnel in city, county, and state, who have or have had administrative and/or supervisory responsibilities for Child Welfare and Attendance.

- A. Classification of Membership Membership shall be on an individual basis. Voting privileges shall be given to those members who are current in their dues and are in good standing.
 - 1. Active Members Actively employed Child Welfare and Attendance personnel.
 - Honorary Life Members Membership bestowed upon any person by majority vote of the Board of Directors. No dues are required.
 - Associate Members Membership includes Child Welfare and Attendance Paraprofessionals and persons in related fields. Dues shall be one half the dues for active members.
 - 4. Institutional Memberships will be made available to agencies and institutions including but not limned to: School districts, office of county superintendent of schools, college: and universities. Institutional membership dues shaft be the same as for active members. Institutional membership shall not be transferable to an individual.
 - 3. Retired Members Members who maintained active membership in the Association prior to retirement and have all the rights and privileges of Active Members. Dues shall be one half the dues for active members.
- B. Honorary Life Members pay no dues and have all the rights and privileges of Active Members, except the right to vote and hold office.
- C. Associate Members have all the rights and privileges of Active Members, but do not vote or hold office.
- C. Members, upon payment of dues, shall become immediately eligible to vote and hold office.

Section 3

The membership year shall be from June 1 to May 31 on an annual basis from the date of enrollment.

Section 4

Membership dues shall be \$30.00 for the Association dues levied; individual sections. This sum is a combined sum and must be collected as one amount. *levied by the State Association*. Sixty percent (60%) of each *the* membership dues shall be forwarded

to retained by the State Association Treasury; forty percent (40%) shall be retained by forwarded to the individual section of the association. This pertains to Active Associate and Institutional Memberships.

ARTICLE VI Governing Body

Section 1 - Governing Bodies

The California Association of Supervisors of Child Welfare and Attendance, Southern Section, shall consist of two governing bodies, the Executive Committee and the Executive Board of Directors.

Section 2 - Executive Committee

The Executive Committee shall be composed of the elected officers and the immediate Past-President. Meetings shall be called by the President at whose discretion additional representatives may be invited.

Vacancies on the Executive Committee, with the exception of the President, shall be filled by appointment of the President with the approval of **a majority of** the remaining members of the Executive Committee. Such appointees shall hold office for the remainder of the unexpired term. The President-Elect shall succeed to the office of President in case of a vacancy in that office.

Section 3 - Executive Board of Directors

The Executive Board of Directors, hereafter referred to as the Board, shall be composed of the members of the Executive Committee, Members-at-Large, Area Representatives, and chairpersons of all standing committees who are appointed by the President, with the approval of the Executive Committee.

Meetings of the Board shall be scheduled on a monthly basis during the school year. All meetings are open to current members of CASCWA, Southern Section the association. Only Board members shall be eligible to vote. A simple majority shall constitute a quorum.

ARTICLE VII Officers, Elections, Duties

Section 1

The elected officers shall be President, President-Elect, Vice-President, Secretary and Treasurer.

Section 2

The election of officers shall take place by mail ballots, via U.S. mail or email, of members paid up as of March I, before the last section meeting of the current school year. Officers shall hold office for one year or until successors qualify. Officers thus elected, shall take office at the close of the last Section meeting of the current school year and shall serve two year terms of office.

Section 3

Each of the six geographical areas in Southern Section shall have two a voting representatives, appointed by the President, with the approval of the Executive Committee. To assure continuity, each person will serve for a two year period.

Los Angeles Unified School District will have one representative from each of the five administrative regions of the district, representing two votes total for the district as area representatives.

Section 4

The President, Past President, President-Elect, Vice-President, Secretary, and Treasurer shall perform the duties regularly assigned to such offices.

Section 5

The President shall preside at all meetings of the **Executive Committee and the** Board **of Directors** and shall perform all duties usually assigned to a President.

- A. The President shall appoint two (2) auditors at the final Executive Board of Directors meeting to audit the books of the treasurer.
- B. The President shall appoint, subject to approval of the Executive Board, a Newsletter Editor or Co-Editors, who shall serve as members of the Executive Board.
- **B.** The President shall appoint, subject to approval of the Executive Board of Directors, Chairpersons of all standing and special committees.
- C. The President shall be an ex-officio member of all committees with the exception of the Nominating
- D. The President shall be empowered to sign checks in payment of bills as authorized by the Executive Board of Directors in lieu of the Treasurer, if for any reason it is not possible or expeditious for the Treasurer to do so. In such cases, a single signature shall be sufficient.

Section 6

The President-Elect shall serve as Chairperson of the Program Committee, which will develop all workshops and conferences to be presented yearly. The President-Elect shall also serve as Chairperson of the Constitution Revision Committee, which shall consist of three area representatives and any others members appointed by the President. The President-Elect shall preside at meetings when the President is absent.

Section 7

The Vice President shall serve as Chairperson of the Membership Committee. This committee will consist of the Treasurer and all Area Representatives. This committee will develop the plans for recruitment and membership.

Section 8-7

The Secretary shall:

- A. Act as Secretary to the Association and Executive Board Executive Committee and the Board of Directors and shall record the minutes of each meeting. These minutes shall be retained as permanent records of the Association.
- Furnish all members of the Executive Board with a copy of the minutes of each meeting.
- C. Serve as an ex-officio member of the Membership Committee and perform all duties stipulated in the By Laws of the Association.
- C. Be responsible for coordinating all Association elections.

Section 9 8

The Treasurer shall:

- A. Maintain and disburse all funds, pay all bills and be prepared to give a report on the financial condition of the funds of the association at each meeting of the Executive Board.
- B. Deposit all funds of the Association in a bank authorized by the Executive Board.
- C. Pay all bills.
- D. C. Serve as a member of the Membership Committee and perform such duties connected with this committee as stipulated in the By-Laws of the Association.
- **E.** C. The Treasurer shall prepare and submit a proposed budget to the Executive Board, at its first meeting in September.

Section 10-9

Memberships-at-large shall be appointed by the President to serve in an advisory capacity to the Executive Board of Directors and shall have voting rights.

ARTICLE VIII Standing Committees

There shall be nine standing committees of the Association, namely: 4. **A.** Legislative; 2- **B.** Nominating; 3- Membership; 4- Professional Standards; 5- Public Relations; 6. **C.** School Attendance Review Board; 7- Student Rights and Responsibilities; 8- Para Professionals; 9- Life Membership. **D.** Scholarship; **E.** Newsletter

- A. The Legislative Committee is responsible for informing the membership about new and proposed legislation affecting welfare and attendance.
- B. The Nominating Committee shall prepare a slate of officers to be submitted to the Executive Committee. The Executive Committee shall present the slate to the membership.
- C. The Membership Committee shall provide leadership in cooperation with Area Representatives, in stimulating membership in the Association and assist the Treasurer in every way possible in the collection of dues.
- D. The Professional Standards Committee shall be responsible for keeping membership informed about professional needs and standards, in the areas of pupil personnel services, as they relate to Child Welfare and Attendance.
- E. The Public Relations Committee is responsible for leadership in internal and external communications.
- C. The School Attendance Review Board Committee shall respond to membership concerns and informational needs regarding due process, student rights, school/parent rights, student responsibilities, school/parent responsibilities, and other such data and guidelines needed to clarify and provide leadership in these areas. The committee will further provide information and publication of documents and reports to assist members to develop programs in taking the leadership in this area.
- D. The Student Rights and Responsibilities Committee shall address current issues, recent court decisions and issues of individual rights. In addition, this committee shall promote responsible citizenship.

- E. The Paraprofessional Committee shall assist the Association by strongly supporting the paraprofessional personnel.
- F. The Life Membership Committee shall identify members and provide appropriate recognition for recipients at the appropriate function. Shall maintain active registers of those awarded Honorary Life Memberships.
- D. The Scholarship Committee shall solicit from members nominations of high school seniors who have overcome adversity within their homes, schools, or communities and are on track to graduate successfully from their respective high schools or alternative programs. From these nominations, final selections will be made and awarded scholarships to be used for their post-secondary education. The scholarships, in the form of financial awards, will be forwarded to the recipients upon evidence of enrollment in these post-secondary programs.
- E. The Newsletter Committee shall be responsible for the collection and selection of articles and other materials for publication in the section newsletter, The CASCWA Connection.

The Chairperson of each of these Standing Committees and such other special committees as authorized, are directly responsible to the President and the Executive Board of Directors. The Chairperson shall also be responsible at the end of the year for presenting to the President, a summary of the Committee accomplishments and any suggestions and recommendations.

The revised copy of the Constitution and Bylaws shall bear: the date of the revision; the name of the Association President on that date; and the location of the Executive-Board of Directors meeting where the revisions were declared official.
